From the intersection of US 17-92 (Woodland Blvd.) and SR 44 (New York Ave.), proceed west on New York to North Clara Ave. Turn right on Clara Ave. The Complex is one block north on the left.

- DB Proceed west on US 92 (ISB) to US 17-92 (Woodland Blvd.). Turn left and proceed to Plymouth Ave. Turn right and proceed two blocks to Clara Ave. Turn left and travel about 4 blocks.
- I-95 Exit I-95 at the US 92 (ISB) exit. Travel west to US 17-92 (Woodland Blvd.) in DeLand. Turn left and proceed to Plymouth Ave. Turn right and proceed two blocks to Clara Ave. Turn left and travel about 4 blocks.
- I-4 Exit at SR 44 (exit 56/118) and proceed west. Proceed to DeLand and cross Woodland Blvd. to North Clara Ave. Turn right at Clara Ave. Administration building is one block north on the left.
- NSB Take SR 44 west to US 17-92 (Woodland Blvd.) in DeLand. Cross 17-92 (Woodland Blvd.) and proceed to North Clara Ave. Turn right on Clara Ave. and travel about two blocks.
- NW Take SR 17 to US 92 (ISB). Continue on 17-92 to Plymouth Ave. Turn right and proceed two blocks to Clara Ave. Turn left and travel about 4 blocks.

**EDC Atlantic** - 1250 Reed Canal Road, Port Orange 32129

From the intersection of US 92 (ISB) and Nova Road in Daytona, drive south on Nova to Reed Canal Road. Turn right on Reed Canal Road and proceed west about one quarter mile.

- I-95 Exit at SR 400 (Beville Road) and proceed east to Clyde Morris Blvd. Turn right and proceed to Reed Canal Road. Turn left on Reed Canal Road and travel east about one half mile.
- I-4 Take I-4 east to its end at SR 400 (Beville Road). Proceed on Beville Road to Nova Road. Turn right on Nova and proceed to Reed Canal Road. Turn right on Reed Canal Road and travel about one quarter mile.
- NSB Take US 1 north to Nova Road. Continue north on Nova to Reed Canal Road. Turn left on Reed Canal Road and travel east about one half mile.

NW Take SR 40 east to Nova. Turn right on Nova and travel south through Daytona to Reed Canal Road. Turn right on Reed Canal Road and proceed west about one quarter mile.

Take SR 17 to DeLand. Turn left on 17-92 (ISB) and travel to Daytona. Turn right on Nova Road and proceed on Nova to Reed Canal Road. Turn right on Reed Canal Road and proceed west about one quarter mile.

Turn right on Indian Lake Road and travel north approximately ½ mile to the intersection of Olson Dr. Turn right on Olson Dr. and travel east approximately ¼ mile. The facility is on the left.

I-4 Exit I-4 at US 92. Travel west on US 92 to Indian Lake Road. Turn right on Indian Lake Road and travel north approximately ½ mile to the intersection of Olson Dr. Turn right on Olson Dr. and travel east approximately ¼ mile. The facility is on the left.

W From the intersection of US 17-92 (Woodland Blvd.) and US 92, proceed east on US 92 approximately 13 miles to the intersection of Indian Lake Road. Turn left on Indian Lake Road and travel north approximately ½ mile to the intersection of Olson Dr. Turn right on Olson Dr. and travel east approximately ¼ mile. The facility is on the left.

From the intersection of US 92 (ISB) and Nova Road, proceed south on Nova to Herbert St.. Turn right on Herbert.

I-95 Exit at Dunlawton Ave. (exit #85). Proceed east on Dunlawton to Clyde Morris Blvd. Turn left and proceed to Herbert St. Turn right on Herbert.

I-4 Exit at I-95 and travel south. Exit I-95 at Dunlawton Ave. (exit 85). Proceed east on Dunlawton to Clyde Morris Blvd. Turn left and proceed to Herbert St. Turn right on Herbert.

NSB Take US 1 north to Nova Road. Continue north on Nova to Herbert St. Turn left.

NW Take SR 40 east to I-95 and proceed south. Exit I-95 at Dunlawton Ave. (exit 85). Proceed east on Dunlawton to Clyde Morris Blvd. Turn left and proceed to Herbert St. Turn right on Herbert.

Take US 17 to DeLand. Travel east on US 92 to Daytona. Turn right at Nova Road. Proceed south on Nova to Herbert St. Turn right on Herbert.

From the intersection of US 92 (ISB) and Nova Road, travel south on Nova Road to Beville Road. Turn right on Beville, travel west to Forest Lake Blvd, turn right then make right on Hancock Blvd.

I-95 Exit at SR 400 (Beville) and proceed east to Forest Lake Blvd and turn left. Proceed to Hancock Blvd. and turn right. Transportation is on the left.

I-4 Exit I-4 at SR 400 (Beville) and proceed east to Forest Lake Blvd and turn left. Proceed to Hancock Blvd. and turn right. Transportation is on the left.

NSB Take US 1 north Nova Road. Turn left on Nova Road and proceed to Beville Road. Turn left on Beville Road and travel to Forest Lake Blvd. Turn right on Forest Lake Blvd. and then turn right on Hancock Blvd. Transportation is on the left.

NW Take SR 40 east to I-95 and proceed south. Exit at SR 400 (Beville) and proceed east to Forest Lake Blvd and turn left. Proceed to Hancock Blvd. and turn right. Transportation is on the left.

Take US 17 to DeLand. Travel east on US 92 to Clyde Morris Blvd. in Daytona. Turn right (south) on Clyde Morris Blvd. and proceed to Hancock Blvd. Turn right on Hancock Blvd. Transportation is on the right.

From the intersection of US 17-92 (Woodland Blvd.) and SR 44 (New York Ave.), proceed north on US 17-92; turn right at US 92 (ISB). The Warehouse Department is located east on ISB about one mile from intersection of US 17 and US 92 (ISB). Turn left on Detrick Ave. (DeLand Airport) and take the first right on Shapiro Dr.

- I-95 Exit at US 92 (ISB) (exit 87). Travel west about 20 miles to the DeLand Industrial Park. Turn right on Detrick Ave. and proceed one block to Shapiro Dr. Turn right and travel one block. The Central Warehouse Services will be on the left. Copy Center and DeLand Transportation are also in this complex.
- I-4 Exit at SR 44 (exit 56/118) and travel west on SR 44 to the first traffic signal at Martin Luther King Blvd/Kepler Road. Turn right and continue to the traffic signal at US 92 (ISB). Turn left and travel about one mile to the DeLand Industrial Park. Turn right on Detrick Ave. and proceed one block to Shapiro Dr. Turn right on Shapiro and travel one block. The Central Warehouse Services will be on the left. Copy Center and DeLand Transportation are also in the complex.
- I-75 Exit at Ocala (exit 65) SR 40. Proceed east on SR 40 to Barberville (US 17). Turn right on US 17 and proceed to US 92 (ISB). Turn left on ISB and proceed about one mile to the DeLand Industrial Park. Turn left on Detrick Ave. and travel one block to Shapiro Dr. Turn right on Shapiro and travel one block. The Central Warehouse will be on the left. Copy Center and DeLand Transportation are also in this complex.
- NSB Proceed on SR 44 towards DeLand. Travel west on SR 44 to the first traffic signal at Martin Luther King Blvd/Kepler Road. Turn right and continue to the traffic signal at US 92 (ISB). Turn left and travel about one mile to the DeLand Industrial Park. Turn right on Detrick Ave. and proceed one block to Shapiro Dr. Turn right on Shapiro and travel one block. The Central Warehouse Services will be on the left. Copy Center and DeLand Transportation are also in this complex.
- NW Proceed on US 17 to DeLand. Turn left at US 92 (ISB). The Warehouse Department is located east on ISB about one mile from intersection of US 17 and US 92 (ISB). Turn left on Detrick Ave. (DeLand Airport) and take the first right on Shapiro Dr.

I-95 Exit I-95 at I-4 and proceed west. Exit I-4 at SR 472 (exit 54/114) (Howland Blvd.) and travel east to Catalina Blvd. Turn right on Catalina and proceed to Eustace Ave. Turn left on Eustace.

- I-95 Exit at SR 40 and proceed east to US 1. Turn right onto US 1/Yonge Street, left onto Central Ave. and then left into the complex.
- I-4 Take I-4 to I-95 north and exit at SR 40 (exit 268). Travel east on SR 40 and turn right onto US1/Yonge St. Turn left onto Central Ave. and left into the complex.
- NSB Take US 1 north to Ormond Beach past Division. Turn right onto Central Ave. and left into the complex.
- NW Take SR 40 east to US 1/Yonge St. Turn right on US 1/Yonge Street. Turn left onto Central Ave. and left into the complex
