 - 2. innovative learning modality —the district will provide written confirmation of a student's progress to the parent. This will require parents to sign and return if they wish to keep their student under this learning format if their student is not progressing. This document must be available for the department of education.
 - 3. provide enhanced outreach of truancy and outreach of students
 - 4. professional learning for administrators and teachers
