- Home Education students are eligible to participate in partial enrollment provided the following conditions are met:
- The student has met all related criteria pursuant to Section 1002.41, Florida Statutes including submission of a satisfactory evaluation for the previous school year.
  - The student who wishes to enroll in a course in order to be eligible to participate in the related interscholastic extracurricular activity may do so with or without prior enrollment in home education, provided they have met the academic eligibility requirements outlined by FHSAA, school board policy, or other pertinent/relevant state activities associations.
  - The student must meet the same registration requirements as full-time students and must register prior to the start of the semester they will attend.
  - The student who is excluded from a class/course at the zoned school due to space limitations may attend another school if space in that class/course is available and a variance is granted.
  - The student will be subject to all applicable rules and regulations pertaining to full-time students, including required immunizations.
  - The student and parent/guardian have received and understand the Code of Student Conduct and Discipline/Student and Family Policy Guide.
  - The parent/guardian agrees to provide transportation for the student to and from all classes/courses.

OTHER PROVISIONS OF PARTIAL ENROLLMENT POLICY #210

The school principal will establish the time and place for arrival and departure of home education students who are participating in partial enrollment.

Students enrolled in public school full time will be given priority in course registration.

Students in Exceptional Student Education will be provided services as required by law. All home education students requesting partial enrollment who have previously received special education (Exceptional Student Education) services shall receive a case review, in accordance with federal law.

Work, credits, or evidence of achievement of a student transferring into a Volusia County public school from a non-accredited school, public or non-public, or a home education program shall be evaluated by the principal or designee. An appropriate achievement or subject-level test may be used to determine grade placement if deemed necessary.

Attendance on a part-time basis does not entitle the student to participate in non-interscholastic extracurricular activities, including graduation events.
