RESOLUTION NO. 2018-16

**A RESOLUTION OF THE SCHOOL BOARD OF VOLUSIA COUNTY, FLORIDA, LEVYING THE TENTATIVE AD VALOREM PROPERTY TAX MILLAGE RATE FOR 2018-2019 REQUIRED LOCAL EFFORT, REQUIRED LOCAL EFFORT-PRIOR PERIOD ADJUSTMENT, DISCRETIONARY OPERATING, ADDITIONAL OPERATING FOR THE GENERAL FUND AND DISTRICT DISCRETIONARY LOCAL CAPITAL IMPROVEMENT FOR THE CAPITAL FUNDS , AND DEBT SERVICE FOR THE DISTRICT DEBT SERVICE FUNDS ON ALL TAXABLE PROPERTY WITHIN VOLUSIA COUNTY, FLORIDA, FOR THE FISCAL YEAR BEGINNING JULY 1, 2018, AND ENDING JUNE 30, 2019, STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS HIGHER THAN THE ROLL-BACK RATE; REPEALING ALL RESOLUTIONS IN CONFLICT THEREWITH; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the School Board of Volusia County, Florida, is authorized under the Constitution and Laws of Florida to levy a tax upon non-exempt real property, lying and situated in Volusia County, Florida, for public school purposes, and

**WHEREAS**, the required public notice has been given, and the public has been given an opportunity to be heard and to ask questions concerning the tentative millage rate for the 2018-2019 fiscal year, and

**WHEREAS**, all matters required by law pursuant to the adoption of the tentative millage rate for 2018-2019 have been accomplished,

**NOW, THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF VOLUSIA COUNTY, FLORIDA, IN OFFICIAL SESSION, DULY ASSEMBLED IN DELAND, FLORIDA, THIS 24<sup>th</sup> DAY OF JULY, 2018, AS FOLLOWS:**

I. That the following millage rates be tentatively adopted for potential levy upon all taxable real property lying and situated in Volusia County, Florida, for the 2018-2019 fiscal year:


A. For the Required Local Effort	4.026
B. For the Required Local Effort-Prior Period Adjustment	0.007
C. For the Discretionary Operating Effort	0.748
D. For Discretionary Local Capital Improvement	1.500
E. For the Debt Service	0.000
<b>Total Millage Rate</b>	<b>6.281</b>


The total millage rate for fiscal year 2018-2019 of 6.281 Mills (as calculated excluding Debt Service rate of 0.000) is 3.51% higher than the rolled-back rate of 6.068 Mills computed pursuant to section 200.065(1), F.S.


